

**TEXAS PUBLIC EDUCATION GRANT-DUAL CREDIT  
ACADEMIC YEAR 2014-2015**

The Texas Public Education Grant (TPEG) may be awarded to cover fees for courses taken through the Dual Credit Program. Students must be accepted into the Dual Credit Program prior to applying for financial assistance. Awards will be based on financial need and **the availability of funds.**

**Application Process**

All applicants **must submit:**

1. **Electronically submit the Free Application for Federal Student Aid (FAFSA)** Use "FAFSA On The Web" at [www.fafsa.ed.gov](http://www.fafsa.ed.gov) to submit your 2014-2015 Federal Student Aid Application.
2. A copy of parent's **2013 IRS tax return transcript(s)**. To obtain an IRS tax return transcript, go to [www.irs.gov](http://www.irs.gov) and click on the "Get Transcript for My Tax Records" link to print view and print your transcript immediately. You may also utilize the IRS Data Retrieval Tool when completing the FAFSA (which is recommended).
3. Attach proof of any **untaxed income.**
4. Attach completed **2014-2015 Status 1 Dependent Verification Worksheet.** Go to [www.delmar.edu](http://www.delmar.edu), click on "Paying for College," then click on Forms. The form is available for printing.
5. Submit completed application packet to **Financial Aid Services, Del Mar College, 101 Baldwin Blvd., Corpus Christi, TX 78404-3897.**

It is recommended that this packet be submitted with all required documentation to meet our priority deadline of July 1, 2014. Incomplete application packets will not be considered, due to limited funds. You will be notified of the results of your application.

Please remember that the Del Mar College Dual Credit Grant will cover **only fees. Funds are limited.**
